This is general statement on its data processing activities to notify Data Subjects of categories of Personal Data processed and the purpose and extent of processing. This is not a consent form but a notification how we processes Personal Data in its established practices and operations.

What personal data does Hotel Savano

collect from you?

We only collect the Personal Data needed to effectively serve you and carry out our business operations and obligations. This may include your basic personal details such as name, age, birthday, address, nationality, contact information, contact of personal information of your relatives, guardian or next of kin. In some situations, we may also collect medical information and health profile for us to customize our products and services according to your needs.

Why does Hotel Savano collect and process

your Personal Data?

We collect only the Personal Data needed to effectively serve you and carry out its business operations and obligations. We may collect, use, and process your Personal Data for the following general purposes –

- a. To conduct due diligence prior to executing a contract, and to facilitate the fulfillment of the terms of the contract thereafter (i.e. bookings, reservations, employment, supplier agreements);
- b. to respond to queries, complaints, and requests;
- c. to provide information about our services and products and promote effectively them;
- d. to conduct research and analysis to improve customer experience, management system, eternal or internal controls;
- e. to maintain safety and security; and
- f. to comply with legal, regulatory, and contractual requirements or obligations.

We may further provide specific privacy notices in line with specific activities or objectives. Rest assured that we process Personal Data proportionately and as may be necessary to serve legitimate purposes in accordance with laws and regulations, as well as our Policies

How does Hotel Savano collect your

Personal Data?

Depending on a particular transaction and your preference, we collect your Personal Data *physically* through printed forms, attachments, and other document, or *electronically* through electronic systems, electronic platforms, e-forms, email, or electronic submission of information directly through you or through your representatives.

When does Hotel Savano collect personal data

collect from you?

We generally collect your Personal Data upon your entry to our establishment (CCTV or entry records), or at the onset of your transaction with us, such as inquiry, reservation, booking and our other services.

What is Hotel Savano's general policy on storage, transmission and transfer of Personal data collect from you?

Personal Data are stored in physical and electronic data processing systems managed by our groups, offices, and units. Physical records are generally stored in folders or envelopes in drawers or shelves. Electronic records are generally stored in servers in our possession or control, or in cloud storage that we control or availed. Personal Data are transmitted and transferred in accordance with Chapter III of the Data Privacy Act of 2012 and Rule V of its Implementing Rules and Regulations.

How long does Hotel Savano keep Personal Data?

Retention period for Personal Data we collect varies on the kind of transaction. We retain data in accordance with our retention policies, observing laws and government rules and regulations, and locally and internationally accepted practices and standards.

What are your rights as Data Subject?

As provided by law, you may object to the processing of your personal data, request to access your personal information, and/or have it corrected, erased, or blocked on reasonable grounds. We will consider your request and reserves the right to deal with the matter in accordance with the law.
